## 4920. Police Report

Holsworthy Rural Policing Update 1/9/18 – 31/10/18:

The following crimes have been reported:

**ASHWATER:** Common assault – vehicle driven towards aggrieved causing them to fear for their safety.

In charge of motor vehicle whilst unfit through drink or drugs

**BLACK TORRINGTON:** Theft of light from outside dwelling

**BRADFORD:** Theft from motor vehicle

Theft of wheelie bins

**BRADWORTHY:** Dog dangerously out of control

BRIDGERULE: Criminal damage – cat found dead, by unknown means

**HOLSWORTHY HAMLETS:** Theft from motor vehicle

ST GILES ON THE HEATH: Theft of building materials from garden

We are aware that there have been a large number of thefts from work vans across the force as a whole, although we've had only one reported incident in Holsworthy and the surrounding parishes. We would advise anyone owning such a van, which contains valuable equipment or tools, to take appropriate security measures, and to report any suspicious activity to the Police.

### **4921.** District Councillors Report

The new Local Plan is going well. Workshops will be held in the new year, with details coming out in January. It would be beneficial for someone from the council to attend.

### 4922. County Councillors Report

No provisional settlement has been agreed yet for the budget, with what is currently happening in central government.

There are issues with funding for children's services, there is a £6million deficit. Trying to rebalance the budget by pulling money from other services, but there is still uncertainty on the budget at the moment.

More funding has been received from central government for highways, and extra £18million. Much of this money will go towards repairing bridges across the county, and the balance of the funds, is yet to be decided.

Cllr Parsons will not be about in January.

#### 4926. War Memorial on Village Green

The land owned by the parish needs registering as such with Land Registry. A subcommittee to be set up to look at, Cllrs Worden, Perkin, James and Crocombe.

The area by the footpath needs tidying up. Will arrange to meet in January.

### 4928. First Aid Course

Cllr James suggested the parish put on a First Aid and CPR course in the parish, as a defib is not a practical solution as the parish is so spread out. To look at using Roadford. To bring to next meeting.
